**NOTICE OF INTENTION TO APPLY TO STOP UP THE HIGHWAY AT
DALLAS COURT, DALCROSS COURT AND ENDERBY GARDENS, HEMLINGTON,
MIDDLESBROUGH**

NOTICE is given that The Council of the Borough of Middlesbrough as Highway Authority intends to apply to Teesside Magistrates Court sitting at the Law Courts, Centre Square, Middlesbrough on 23rd March 2023 at 10am for an Order under section 116 of the Highways Act 1980 authorising the stopping up of an area of the highway as described in the Schedule hereto and shown hatched and edge black on the plan on the grounds that they are unnecessary.

Any person to whom this Notice has been given or who uses the highway specified or who would be aggrieved by the making of the Order may appear before the Magistrates' Court to raise an objection or make a representation on the application. Any person intending to appear before the Magistrates' Court at the hearing of the application is requested to inform Middlesbrough Council Legal Services at the address below before the 23rd March 2023 quoting reference SCM15899.

The footpath (Location 1 on the order plan) which starts at Grid Ref NZ 49059 / 14279 to the rear of No. 75 and 77 Dallas Court and proceeds in a south easterly direction for approx. 9.9 m to Grid Ref NZ 49064 / 14270 between No. 75 and 77 Dallas Court. (Approx. area to be stopped up 26 Sqm).

The footpath (Location 2 on the order plan) which starts at Grid Ref NZ 49084 / 14233 to the rear of No. 39 and 41 Dallas Court and proceeds in a south easterly direction for approx. 19.1 m to Grid Ref NZ 49093 / 14216 to the front of No. 39 and 41 Dallas Court. (Approx. area to be stopped up 51 Sqm).

The footpath (Location 3 on the order plan) which starts at Grid Ref NZ 49096 / 14209 to the rear of No. 5 and 7 Dallas Court and proceeds in a south easterly direction for approx. 20.3 m to Grid Ref NZ 49106 / 14191 to the front of No. 5 and 7 Dallas Court. (Approx. area to be stopped up 58 Sqm).

The footpath (Location 4 on the order plan) which starts at Grid Ref NZ 49186 / 14271 to the rear of No. 93 Dalcross Court and proceeds in a south easterly direction for approx. 18.8 m to Grid Ref NZ 49191 / 14253 to the front of No. 93 Dalcross Court. (Approx. area to be stopped up 51 Sqm).

The footpath (Location 5 on the order plan) which starts at Grid Ref NZ 49173 / 14233 to the rear of No. 115 and 117 Dalcross Court and proceeds in a south easterly direction for approx. 19.7 m to Grid Ref NZ 49178 / 14214 to the front of No. 115 and 117 Dalcross Court. (Approx. area to be stopped up 57 Sqm).

The footpath (Location 6 on the order plan) which starts at Grid Ref NZ 49197 / 14241 to the rear of No. 107 and 109 Dalcross Court and proceeds in a south easterly direction for approx. 18.5 m to Grid Ref NZ 49202 / 14223 to the front of No. 107 and 109 Dalcross Court. (Approx. area to be stopped up 46 Sqm).

The footpath (Location 7 on the order plan) which starts at Grid Ref NZ 49340 / 14287 to the rear of No. 5 and 7 Enderby Gardens and proceeds in a southerly direction for approx. 19.5 m to Grid Ref NZ 49340 / 14267 to the front of No. 5 and 7 Enderby Gardens. (Approx. area to be stopped up 56 Sqm).

The footpath (Location 8 on the order plan) which starts at Grid Ref NZ 49439 / 14179 to the front of No. 60 and 62 Eddison Way and proceeds in an easterly direction for approx. 12.1 m to Grid Ref NZ 49451 / 14179 to the rear of No. 60 and 62 Eddison Way. (Approx. area to be stopped up 22 Sqm).
